- 1. Discussion of 107 Robin Variance Segars stated the applicant wished to withdraw the request without prejudice. - 4. Approval of Bid for Concrete Patio Replacement DeLaSalle moved to approve the bid from Josh at C&S Concrete. 2nd by Carlson. Belser expressed concern the bid lacked the detail found in the other two and wanted to make sure the bids were for the same product. He also asked if references were checked. DeLaSalle withdrew his motion to get more information from C&S. 2nd withdrawn by Carlson.
- 5. Approval of Resolution R99-18 Adopting Drug and Alcohol Policy Murphy moved to approve. 2nd by DeLaSalle. Approved 4-0-0.
- Appointment to Fill Vacancy of Gladney Cooper Still announced Joyce Ayers had come forth to fill the vacancy. Carlson moved to appoint Ayers. 2nd by Belser. Belser advised a term adjustment was still needed at the next cycle. Approved 4-0-0.
